
Campus Connection Delegated Access- Proxy

This training document will show the Proxy how to register an account and view student's Campus Connection Data.

Registration

1. Read the email that you receive. This email will have an important link and security key that is needed for registration.

Instructions:

- 1. Click this link to access Campus Connection. You will be asked to sign in using your existing Proxy User ID to access our site. If you are an NDUS Employee, please create a new User ID with prxy. at the beginning.
- 2. After signing in to our system, you will be required to accept or decline the "Terms and Conditions for accessing somebody else's data".
- 3. You will also be required to enter the following two pieces of information:
 - a) The **Security Key:** 3RjPM5i
 - b) The email address where we sent you this notification.



Terms and conditions for accessing somebody else's data


Terms and Conditions
