What is MSEP?

Midwest Student Exchange Program (MSEP) is a program that enables residents in nine midwestern states to enroll at Dickinson State University at reduced tuition levels.

Who may participate?

All programs at Dickinson State University are open on space availability status to MSEP students. Any student who resides within any of the following states may participate if they meet DSU admission requirements:

How do you become eligible?

Students who desire to attend Dickinson State University at the MSEP tuition rate **MUST** complete a MSEP APPLICATION FORM in order to qualify for this program. This form must be completed prior to the first day of class within the term for which MSEP status is being requested.
