

Western Undergraduate Exchange (WUE)

What is WUE?

Western Undergraduate Exchange (WUE) is a program that is coordinated by the Western Interstate Commission for Higher Education (WICHE). WUE enables residents in 12 participating western states to enroll at Dickinson State University at reduced tuition levels.

Who may participate?

All programs at Dickinson State University are open on space availability status to WUE students. Any student who resides within any of the following states may participate if they meet DSU admission requirements:

Arizona
California
Colorado

Hawaii (4 year level only)
Idaho
Nevada
New Mexico

Oregon
Utah
Washington
Wyoming

How do you become eligible?

Students who desire to attend Dickinson State University at the WUE tuition rate MUST complete a WUE APPLICATION FORM in order to qualify for this program. This form must be completed prior to the first day of class within the term for which WUE status is being requested.
